Dear Speaker Phelan and Representative Hunter,

As advocates committed to protecting the rights and dignity of all individuals, including people living in and traveling through the State of Texas, we stand in solidarity with Texans who are sounding the alarm on HB 20¹ and HB 7.² These bills would codify Governor Abbott's illegal and unconstitutional Operation Lone Star (OLS). Since 2021, OLS has violated the due process rights of asylum seekers and U.S. Citizens and Nationals alike,³ promoted racial profiling,⁴ and fueled anti-immigrant rhetoric⁵ that harms all of our communities. Governor Abbott has already misused over \$4 billion in Texas resources to fund OLS, while ignoring the real needs of Texans.⁶ We support Texans who are demanding protection from these harmful bills and from Operation Lone Star. We stand alongside those Texans and ask you to vote "no" on HB 7 and HB 20.

HB 20 and HB 7 will harm not only migrants, but all Texans. Under OLS, not only are migrants being unlawfully targeted for arrest and apprehension by state law enforcement, but border communities are even further militarized. Local residents are witnessing an increase in racial profiling and high speed chases that have resulted in deaths. HB 20 would further increase this harm by creating a "Border Protection Unit" (BPU) within the Department of Public Safety that would be composed of not only law enforcement officials but civilians, including potential vigilante groups, who would have unchecked power to racially profile, "arrest," and "detain" individuals they suspect of being in the United States without legal status. Under HB 20, members of the BPU could apprehend Texans without incurring any legal liability. HB 20 would be an open call for vigilante groups to go to Texas to harm and harass asylum seekers and Texas residents – something we have already seen happen without the lure of state approval and protection from liability.

HB 20 criminalizes the right to seek safety in the United States and inhumanely creates barriers preventing vulnerable communities from accessing the asylum system. The bill would create a brand new felony trespassing offense for migrants, inhumanely criminalizing individuals attempting to access asylum who travel through private property and forcing them to pay a minimum \$10,000 fine. 11 On its face, the bill's broad language also appears to apply not only to asylum seekers, but anyone who enters from a "neighboring jurisdiction." HB 20 also creates a Texas-equivalent of Title 42, allowing state officials to remove anyone, excluding U.S. Citizens or lawful permanent residents, who entered into Texas (from anywhere) without an "appropriate medical review." 13

HB 20 would divert billions of state resources to fund the unconstitutional OLS scheme. Governor Abbott's prioritization of OLS has already misused \$4 billion of state funds and the scheme is costing Texans \$100 million each month. These funds, and funds allocated by the Texas Legislature should be used to address what Texans say matters most, like supporting

state employees,¹⁵ teachers and students,¹⁶ expanding access to medical care,¹⁷ and supporting the state's electric grid system.¹⁸

HB 7 would create "border protection" courts that would further violate the due process rights of migrants and U.S. Citizens and Nationals. 19 OLS has already led to numerous due process violations, and these "border protection" courts would promote further violations against asylum seekers and others charged under this unlawful system. A state prosecutor, tasked with prosecuting OLS cases, has already called OLS a "waste of time and money." Despite this, HB 7 would codify this sham court system, requiring a further drain of Texas resources.

Texas communities should be admired for their diversity, communal spirit, and welcoming nature. Bills such as HB 20 and HB 7 look to install border militarization and OLS as a permanent fixture in Texas law. This would destroy all that people love about Texas. We support Texas advocates and community members who openly oppose HB 7 and HB 20. We urge you to protect asylum seekers and protect Texans. Vote "no" on HB 7 and HB 20.
